CUMMINGS, R

ON 2/5/23 I DEPUTY ROBERT CUMMINGS WAS DISPATCHED TO 5179 MAIN ST ANACOCO LA IN REFERENCE TO A FEMALE SUBJECT CATCHING A MALE SUBJECT ENGAGED IN A SEX ACT WITH HER JUVENILE DAUGHTER. DISPATCH ADVISED THE FEMALE COMPLAINANT HAD THE MALE SUBJECT AT GUN POINT.

UPON ARRIVAL AT THE RESIDENCE, I MET WITH A [REDACTED] [REDACTED] STATED THAT THE MALE SUBJECT HAD LEFT IN A RED FORD RANGER TRUCK.

I ASKED HER WHAT HAPPENED. SHE SAID SHE WALKED INTO THE KITCHEN AND WITNESSED HER FIANCE, NAMED THOMAS MCCARTNEY, ON HIS KNEES LICKING HER DAUGHTERS VAGINA. HER DAUGHTER IS 7 YEARS OLD, NAMED [REDACTED] SHE SAID THAT SHE CHASED THOMAS OUT OF THE HOUSE AND HE LEFT IN HIS RED FORD RANGER. SHE THEN ASKED [REDACTED] WHAT HE WAS DOING TO HER. SHE TOLD HER IT WAS A SECRET AND SHE COULDN'T GET HIM IN TROUBLE. SHE TOLD HER TO TELL HER. SHE SAID THAT [REDACTED] SAID HE LICKED HER ON HER PRIVATES. [REDACTED] TOLD HER THAT THOMAS HAS PUT HIS PENIS IN HER BUTT BECAUSE HE CAN'T GET THE "WHITE STUFF" IN HER VAGINA, OR SHE WOULD GET PREGNANT [REDACTED] ALSO TOLD HER THAT HE HAS MADE HER PUT HIS PENIS IN HER MOUTH.

I CALLED SUPERVISOR SULLIVAN AND GAVE HIM THE INFORMATION. HE SAID TO CONTACT [REDACTED]

I CONTACTED [REDACTED] AND GAVE HIM THE INFORMATION I HAD. HE STATED TO HAVE THEM FOLLOW ME TO THE SHERIFFS OFFICE AND HE WOULD BE THERE SHORTLY TO TALK TO THEM. HE ASKED ME TO PHOTOGRAPH THE ROOM THEY WERE IN AND COLLECT THE BEDDING.

[REDACTED] SAID THOMAS WAS CONTINUALLY CALLING HER. I HAD HER ANSWER THE PHONE AND CONFRONT HIM ON THE PHONE ABOUT WHAT HE DID. SHE ANSWERED THE PHONE AND SHE CONFRONTED HIM ABOUT WHAT HE DID. HE DENIED DOING THAT TO [REDACTED] AND SAID, SHE SAID SHE HURT THERE AND HE WAS CHECKING HER FOR PIN WORMS. SHE TOLD HIM HE WAS LYING AND SHE WITNESSED WHAT HE WAS DOING. HE CONTINUALLY DENIED DOING ANYTHING TO [REDACTED] [REDACTED] THEN HUNG UP THE PHONE CALL.

SHE SHOWED ME A PART OF THE KITCHEN WHERE SHE WITNESSED IT. SHE WITNESSED HIM KNELT DOWN ON HIS KNEE IN FRONT OF THE KITCHEN TABLE PERFORMING THE ACT ON HER DAUGHTER. I PHOTOGRAPHED THE AREA.

I THEN ESCORTED THEM TO THE SHERIFFS OFFICE TO MEET WITH [REDACTED].

I HAD [REDACTED] FILL OUT A STATEMENT.

[REDACTED] STATED SHE WAS IN THE BATH WHILE [REDACTED] AND THOMAS WAS UP. SHE WALKED IN THE KITCHEN TABLE AREA AND SAW THOMAS BENT OVER LICKING [REDACTED] PRIVATE AREA. WHEN SHE SAW HIM, HE TOLD HER HE WAS NOT DOING ANYTHING BUT CHECKING HER FOR PIN WORMS BUT SHE SAW EXACTLY WHAT HE WAS DOING TO HER.

[REDACTED] ARRIVED AT THE OFFICE. HE THEN SPOKE WITH [REDACTED] AND CONDUCTED HIS INVESTIGATION.

I SUBMITTED A ARREST WARRANT FOR THOMAS A MCCARTNEY FOR 1ST DEGREE RAPE.

INFORMATION WAS GIVEN OF POSSIBLE LOCATIONS FOR THOMAS. HIS PARENTS LIVE AT 272 PINEWOOD RD. THOMAS HAS A CAMPER BY THEIR RESIDENCE. THOMAS AND [REDACTED] WERE PUTTING A TRAILER ON LAND AT 1163 PIT RD. [REDACTED] ADVISED HE ALSO HAD LAND ON PLANNER MILL RD. SHE SAID HE WORKED FOR A DONALD JONES DOING CONSTRUCTION IN MERRYVILLE.

DONALD JONES CONTACTED THE SHERIFFS OFFICE TO GIVE INFORMATION THAT THOMAS CALLED HIM AND SAID HE WASN'T COMING TO WORK TOMORROW. I TOLD HIM IF HE TALKED TO THOMAS, TO HAVE HIM CONTACT THE SHERIFFS OFFICE BECAUSE WE NEEDED TO SPEAK WITH HIM.

A BOLO WAS GIVEN TO AREA AGENCIES FOR THOMAS'S VEHICLE. DEPUTIES SEARCHED THE POSSIBLE LOCATIONS FOR THOMAS AND COULD NOT LOCATE.
