cominations that would leave some one incapacitated and then drug combinations that would be lethal.									
Warrants were obtained for the defendant's Google, Meta, Apple, and Chat GPT accounts.									
warrants were obtained for the defendant's Google, Weta, Apple, and Chat Gr I accounts.									
The state of the s	endant utilized Chat GPT to research lethal ar								
combinations that could be ingested and injected. The victim reports and provided evidence of his									
incapacitation and a foreign controlled substance in his beverage on 7/12/2025 and 8/18/2025.									
Through email, Chat GPT, Meta messages and Apple records investigators were able to find that the defendant									
research, purchased, and attempted to carry out her plan.									
Syringes, capsule filling kit, medical droppers, scales, medications and other evidence were located within her									
work space at the residence and collected and turned in as evidence.
